<u>Bid Booklet Items</u>: Product prices and Installation prices are listed separately for each item. There is also a separate rate for Rip Up & removal to a Reclamation Center if product can be recycled.

Purchasing products only – Members may choose to purchase carpet/floor tile for one or more projects and then use its own staff to provide installation. In this case, the Member is responsible for room measurements, order estimation, placing and accepting the order, allowing sufficient time prior to commencing installation and product storage prior to installation. The Member will be responsible for any costs associated with product returns and additional orders, except in cases where incorrect or poor quality product was delivered or received. Delivery costs will be the responsibility of the Member but this cost must be declared upfront and included in the order invoice.

The Contractor is responsible for informing the Member about the manufacturing, fulfillment, delivery time frames, shipping information and any return charges and restocking fees associated with the order.

Price Lists for additional products not listed in booklet are available upon request (per manufacturer – listed below). Price Sheet for additional products is attached (listed either as a Markup, or a Discount depending on whether the price is a Retail price or a Wholesale price).

There will be a 50% Restocking Fee plus Freight on returns. Cartons must be unopened.
